



Hon'ble Supreme Court directions - Important recommendations of Dr. Raghavan Committee

- 5.14: Every Institution should engage or seek the assistance of professional counselors to counsel freshers at the time of their admission.
- 5.16: orientation programmes in the institutions including joint sensitization programme by Professional counselor/Principal/Head of the institutions, organizing large scale activities for better interaction among freshers and seniors in the presence of faculty members, addressing students in hostels by Warden, faculty members collectively dining with hostel residents.
- 5.18: Constitution of an Anti-Ragging Committee (ARC) and an Anti-Ragging Squad (ARS) in each institution. The ARC should be headed by Head of the institution (Hof) and should have diverse representation including of local media, civil society, police, faculty, NGOs, parents, students, non-teaching staff, etc. The ARS to be nominated by Hol, should be a smaller body with vigil, oversight and patrolling functions, with members belonging to the various sections of the campus community.
- 5.28: Constitution of a District level Anti Riagging Committee headed by the District Collector / Deputy Commissioner / District Magistrate with the Heads of Higher Education Institutions and Superintendent of Police / SSP of the District as members and representation from local media, NiGOs, students. The Additional District Magistrate should be a member secretary. The District level Committee should hold preparatory meetings during the summer vacation meetings to take stock of the state of preparedness of each institution and their compliance with the policies and directions or guidelines of the appropriate bodies, the university/State/ Central authorities; and this Court's guidelines in regard to curbing the menace of ragging. For larger districts,
- 5.30: Constitution of a Monitoring Cell at University level to coordinate with the affiliated colleges and institutions under its domain. The Cell should review various Anti-Ragging initiatives and should call for reports from the Heads of institutions, keep itself abreast of the decisions of the District level Anti Ragging Committee.
- 5.31: Constitution of a Monitoring Cell at State level at the level of the Chancellor of the State Universities, who may also coordinate with those of the Central Government institutions located in the State in which the Governor has a defined role under the relevant law. The State level Mcnitoring Cell should receive periodically status reports from the University level Monitoring Cells and Districts level Anti-Ragging Committees.
- 5.27: All private commercially managed, lodges or hostels outside campuses must be registered with the local police authorities. The local police, local administration and institutional authorities are to ensure vigil on incidents within the definition of ranging.





#### Salient Features

#### 1.Compliance requirement

Any organization with 10 or more employees must be compliant. Even those organizations that do not have any woman employee need to comply.

#### 2. Requisites of compliance

There are in all eight requirements to be fulfilled:

#### Part A (one time)

- Putting Corporate HR Policy in place particularly with reference to the specific requirements under the Act
- II) Amending Service Rules clearly stating that sexual harassment would amount to misconduct
- III) Setting up Internal Complaints Committee(ICC) in terms of Section 4 of the Act
- IV) Displaying the particulars of ICC members at conspicuous places at the workplace

### Part B (regular basis)

- 1) Technical/legal training of ICC members
- []] Awareness/orientation session for employees
- III) Providing facilities and such information to the ICC for proper handling of complaints according to Principles of Natural Justice
- IV) Preparation and filing of Annual Report at the end of each calendar year

### 3. Composition of Internal Complaints Committee (ICC)

The Internal Complaints Committee shall consist of minimum four members. At least half or more than half of the total members so nominated shall be women. The ICC will be composed of the following members:

l,	Chalrperson	Women working at senior level as employee; if not available then, nominated from other office/unit/department/workplace of the same employer,
2.	2 Members (minimum)	From amongst employees
3.	External Member	From amongst NGOs/associations committed to the cause of women or an individual who is familiar with the issues relating to sexual harassment

Where the offices or administrative units of a workplace are located in different places, division or sub-division, an ICC has to be set up at every administrative unit and office.

### 4. Consequences of non-compliance

Failure of non-compliance attracts a penalty of up to ₹50,000 for the first default and double the amount of penalty and cancellation of license to conduct business in subsequent dereliction.



The Act mandates the ICC to prepare Annual report for a calendar year. Such reports must include the following information:

- a. No. of complaints received
- b. No. of complaints disposed off
- c. No. of cases pending for more than 90 days
- d. No. of workshops/awareness programmes carried out
- e. Nature of action taken by the employer


